Upon completion of said terms of deferred, and fees paid in full, the defendant shall be discharged and his/her conviction set aside as Deferred Disposition. In the event you do not fulfill the requirements of this order and do not show proof by affidavit to the Court, your citation will be entered as a conviction and will be sent to the Department of Public Safety for entry on your driving record as law requires. You will also be liable for the fine amount for your original violation along with any other fees assessed by the Court.
