Building renovation (if over \$100.00 renovation)	90 days	\$50.00
New building permit	9 months	\$50.00 \$200.00/inspection \$0.10/sf
Fence permit	90 days	\$50.00
Portable building	30 days	\$50.00
Demolition permit	6 months	\$50.00
House moving permit (\$1,000.00 bond)	90 days	\$75.00
Electrical permit (if over 25 volts)	30 days	\$75.00
Plumbing permit	30 days	\$75.00
Swimming pool - above ground	30 days	\$50.00
Swimming pool - in ground	90 days	\$100.00
Carnivals/circus	Per event plus terms	\$30.00
Garage/estate sales, limit 2 per calendar year, health certificate must be submitted if selling food	3 days	\$10.00
Fishing permit - daily	1 day	\$5.00
Fishing permit - annual	1 year	\$50.00
Vendor permit - primary person	2 days	\$100.00
Vendor permit - each additional person	2 days	\$20.00

Sign permit fees	30 days	\$75.00
Roofing permit	30 days	\$75.00
Backflow prevention - installation	15 days	\$50.00
Irrigation/sprinkler - installation	90 days	\$50.00

### **City of Rosebud code inspectors' enforcement proceedings:**

- 1. The code officer will give notice of violation and you will have 10 days to correct the violation. If the violation is corrected within 10 days no fine will be issued.**
- 2. If the violation has not been corrected within 10 days a fine will be imposed and you will have to appear before the judge.**

**All property owners will be treated in the same professional and consistent manner. All notifications will be given to businesses and residents, to include city employees and elected officials, when violations are identified.**
